A-C

Achieve	When you want to do something successfully.
Adaptable	Adjusting to a new situation.
Advertise	Promotion of a company or product (in a commercial or advert).
Ambitious	Showing a strong interest to do well and succeed.
Anxious	When you are feeling worried.
Argumentative	Not agreeing, pushing your own opinion.
Artistic	Showing skill in drawing and creating.
Bank	A business that looks after your money. It also lends money.
Benefits	This is extra things that someone receives from their workplace on top of their salary – such as holiday time, or help to pay medical expenses.
Board Director	A member of the group of people who controls the company as a whole.
Borrowing	To take something with a promise to return it.
Budget	A plan for how much money can be spent on different things in an amount of time.
Building Society	A financial organisation, similar to a bank where you can save your money or borrow money.
Business	A place someone works to make money (a company).
Call Centre Telephonist	A person who answers the telephone and answers questions from customers.
Cautious	Taking care to avoid danger or trouble.
Chief Executive Officer	The Chief Executive Officer (CEO) is the top boss of the company.

Challenge	A difficult problem or task.
Claims settler	A person who helps people who have had something stolen or damaged, to help them replace it.
Communication	Sending or giving information and ideas to other people.
Company	A place someone works to make money (a business).
Computer Programmer	A person who designs and writes and tests computer programs.
Confident	When you are sure that something is correct.
Co-operative	Being helpful to others.
Data Processor	A person who organises information into diagrams, tables or reports.
Design	A drawing or a sketch.
Determined	Showing a strong interest to succeed.
Discrimination	Unfair treatment of a person.
Employability	Being able to get and keep work.
Employee	A person who is employed by the company in return for money.
Employment Law	A Set of rules for staff at a company.

Financial Advisor	A person who gives advice on money matters.

Local authority	This is a Government organisation formed in each country, city and borough.

Mortgage Advisor	A person who gives advice on lending money to buy a house.
